1. Township wide alert system

 - Vanessa Dietz responded that she was advised to request three months of severance as a term of her resignation.
 - A motion was made by Smith to accept the resignation of Vanessa Dietz with three months of severance pay, seconded by Belanger. Motion failed. Aye: Smith. Nay: Belanger, Datto, Lanctot, Scholie, Skewes, and Voght.
- A motion was made by Lanctot to terminate the employment of Vanessa Dietz, seconded by Belanger. Motion was carried by a roll call vote. Aye: Belanger, Datto, Lanctot, Scholie, Skewes, and Voght. Nay: Smith.

- A resident that works with Vaneesa expressed support for her.
- A friend of Vanessa read a letter in support.
